This unit was formed in August 1939 as Grenzschutzabschnittskommando 2 (Border Security Command 2). On Oct 15, 1939, it was designated the Höheres Kommando z.b.V. XXXII and assigned first to the Posen area, then on Oct 23, 1939 was transferred to the Lublin, Kielce, Zamosc, and Radom areas and renamed the Höheres Kommando XXXII. At the end of May 1940 it was transferred from Radom to Aachen, where it remained until June 13, 1940. The Corps then moved to the Rouen area for coastal defense between Abbeville on the Somme River and Caen on the Orne River. In May 1942 the Corps was redesignated the Generalkommando LXXXI. A.K.
